This 2025 SERIES E INDENTURE, dated as of February 1, 2025, between the COLORADO HOUSING AND FINANCE AUTHORITY, a body corporate and political subdivision of the State of Colorado (the "Authority"), and COMPUTERSHARE TRUST COMPANY, N.A., a national banking association, duly organized, existing and authorized to accept and execute trusts of the character herein set out under and by virtue of the laws of the United States of America, with a designated office located in St. Paul, Minnesota, as trustee (the "Trustee").

WITNESSETH:

WHEREAS, the Authority has entered into a Master Indenture of Trust, dated as of March 1, 2000 (as amended, the "Master Indenture") with Norwest Bank Colorado, National Association, as predecessor trustee to Wells Fargo Bank, National Association and the Trustee, for the purposes set forth therein; and

WHEREAS, the Master Indenture authorizes the Authority to issue Bonds pursuant to the Master Indenture and one or more Series Indentures; and

WHEREAS, this Series Indenture is supplemental to, and is entered into in accordance with, the Master Indenture; and

WHEREAS, the Authority has determined to authorize the issuance of its Multi-Family/Project Class I Bonds, 2025 Series E-1 (the "2025E-1 Bonds") and its Multi-Family/Project Class I Bonds, 2025 Series E-2 (the "2025E-2 Bonds" and, together with the 2025E-1 Bonds, the "2025E Bonds"); and

WHEREAS, the execution and delivery of this Series Indenture has been in all respects duly and validly authorized by a resolution duly adopted by the Authority; and

WHEREAS, all things necessary to make the 2025E Bonds, when executed by the Authority and authenticated by the Bond Registrar, valid and binding legal obligations of the Authority and to make this Series Indenture a valid and binding agreement have been done.

NOW THEREFORE, THIS 2025 SERIES E INDENTURE WITNESSETH:

ARTICLE I.

AUTHORITY AND DEFINITIONS

- Section 1.1 <u>Authority</u>. This Series Indenture is executed and delivered pursuant to the authority contained in the Act, Section 9.1(e) of the Master Indenture and the Supplemental Public Securities Act, Part 2 of Article 57 of Title 11, Colorado Revised Statutes.
- Section 1.2 <u>Definitions.</u> All terms which are defined in Section 1.1 of the Master Indenture shall have the same meanings, respectively, in this Series Indenture, and, unless the context shall otherwise require, the following terms shall have the following respective meanings:
 - "2025E Bonds" means, together, the 2025E-1 Bonds and the 2025E-2 Bonds.
- "2025E-1 Bonds" means the Colorado Housing and Finance Authority Multi-Family/Project Class I Bonds, 2025 Series E-1 authorized by, and at any time Outstanding pursuant to, the Indenture.
- "2025E-2 Bonds" means the Colorado Housing and Finance Authority Multi-Family/Project Class I Bonds, 2025 Series E-2 authorized by, and at any time Outstanding pursuant to, the Indenture.
 - "Authorized Denominations" means \$5,000 and any integral multiple thereof.
- "Bond Loan Agreement" means the Loan Agreement between the Authority and the Borrower with respect to the Marshall Pointe Loan, as amended and supplemented from time to time.
- "Borrower" means Marshall Pointe Apartments, LP, a Colorado limited partnership, and its successors and assigns.
- "Business Day" means a day on which the Trustee, any Paying Agent, or banks or trust companies in New York, New York, are not authorized or required to remain closed and on which The New York Stock Exchange is not closed.
- "Cash Collateral Amount of the Construction Loan" means an amount up to \$63,000,000. Such amount equals the par amount of the 2025E Bonds, less \$2,265,000, such amount of the proceeds of the 2025E Bonds being deposited into the 2025 Series E subaccount of the Debt Service Reserve Fund.
 - "Class I Parity Ratio" equals, as of the Closing Date, 130%.
 - "Closing Date" means the date of initial issuance and delivery of the 2025E Bonds.
- "Collateral Fund Subaccount" means the subaccount so designated, which is created and established in the 2025 Series E subaccount of the Acquisition Account by Section 5.1(a)(i) hereof.

"Construction Lender" means JPMorgan Chase Bank, N.A.

"Construction Loan" means the construction loan made from the Construction Lender to the Borrower in the original principal amount of \$63,000,000.

"Construction Loan Advances" means any amounts received by the Trustee representing advances to the Trustee on behalf of the Borrower (or an affiliate) or funds from other third parties representing loans or grants of money earmarked for the Marshall Pointe Housing Facility, including but not limited to the proceeds of the Construction Loan.

"Construction Loan Agreement" means the Construction Loan Agreement between the Construction Lender and the Borrower, as amended and supplemented from time to time.

"Construction Loan Prepayment Amount" means an amount necessary to prepay in full the outstanding principal amount of the Cash Collateral Amount of the Construction Loan, together with accrued interest to, but not including, the Conversion Date, as set forth in a payoff statement submitted by the Construction Lender to the Trustee on or prior to the Conversion Date.

"Construction Loan Prepayment Subaccount" means the subaccount so designated, which is created and established in the 2025 Series E subaccount of the Acquisition Account by Section 5.1(a)(i) hereof.

"Conversion Date" has the meaning ascribed to such term in the Bond Loan Agreement.

"Debt Service Reserve Fund Requirement" means, with respect to the 2025E Bonds, as of any date of calculation, an amount equal to two-thirds of the maximum principal and interest payment due for any period of twelve consecutive calendar months on the portion of the Marshall Pointe Loan that is insured or guaranteed by the United States of America and any agency or instrumentality thereof or anticipated to be so insured or guaranteed.

"Electronic Means" means telecopy, facsimile transmission, email transmission or other similar electronic means of communication, including a telephonic communication confirmed by writing or written transmission.

"Funds Exchange Agreement" means the Funds Exchange Agreement (New Loan) of even date herewith between the Authority and the Trustee relating to exchange of funds for purposes of the Authority's private activity bond volume cap recycling program.

"Intercreditor Agreement" means the Intercreditor and Subordination Agreement dated as of February 6, 2025 by and among the Authority, the Construction Lender and the Borrower.

"Interest Accrual Period" means the period during which 2025E Bonds accrue interest payable on any Interest Payment Date. The Interest Accrual Period shall commence on (and include) the last Interest Payment Date to which interest has been paid (or, if no interest has been paid on the 2025E Bonds, from the Closing Date to, but not including, the Interest Payment Date on which interest is to be paid). If, at the time of authentication of any 2025E Bond, interest is in default or overdue on the 2025E Bonds, such Bond shall bear interest from the date to which

interest has previously been paid in full or made available for payment in full on Outstanding 2025E Bonds.

"Interest Payment Date" means each Stated Interest Payment Date and each Maturity Date.

"Marshall Pointe Housing Facility" means the Housing Facility to be known as Marshall Pointe Apartments, to be located at 5170 Marshall Street, in Arvada, Colorado.

"Marshall Pointe Loan" means the Loan made to the Borrower to finance in part the Marshall Pointe Housing Facility.

"Maturity Date" means the respective dates set forth in Section 2.2 hereof.

"MSRB" means the Municipal Securities Rulemaking Board, the current required method of filing of which is electronically via its Electronic Municipal Market Access (EMMA) system available on the internet at http://emma.msrb.org.

"Record Date" means the fifteenth day (whether or not a Business Day) of the month next preceding each Interest Payment Date.

"Restricted Loan Subaccount" means the subaccount so designated, which is created and established in the 2025 Series E subaccount of the Acquisition Account by Section 5.1(a)(i) hereof.

"Risk-Share Insurance Delivery Date" means, with respect to the Marshall Pointe Loan, May 1, 2029, or such later date to which the Authority may consent in writing.

"Series of Bonds" means the 2025E-1 Bonds or the 2025E-2 Bonds, as the case may be.

"Stated Interest Payment Dates" means each April 1 and October 1, commencing April 1, 2025.

(End of Article I)

ARTICLE II.

AUTHORIZATION AND ISSUANCE OF 2025E BONDS

Section 2.1 <u>Authorization of 2025E Bonds.</u> A Series of Bonds, to be issued hereunder in order to obtain moneys to carry out the purposes of the Indenture is hereby created. Such 2025E Bonds shall be issued as Class I Bonds of two tenors, and shall be designated as the "Colorado Housing and Finance Authority Multi-Family/Project Class I Bonds, 2025 Series E-1" and the "Colorado Housing and Finance Authority Multi-Family/Project Class I Bonds, 2025 Series E-2." The Aggregate Principal Amount of 2025E-1 Bonds which may be issued and Outstanding under the Indenture shall not exceed \$55,765,000, and the Aggregate Principal Amount of 2025E-2 Bonds which may be issued and Outstanding under the Indenture shall not exceed \$9,500,000. The 2025E Bonds shall be issued only in fully registered form, without coupons.

Section 2.2 <u>Details of the 2025E Bonds.</u>

(a) The 2025E-1 Bonds shall mature, subject to the right of prior redemption as set forth in Article III hereof, on the dates and in the principal amounts, and shall bear interest, payable on each Interest Payment Date, at the rates per annum, as follows:

(b) The 2025E-2 Bonds shall mature, subject to the right of prior redemption as set forth in Article III hereof, on October 1, 2029, and shall bear interest, payable on each Interest Payment Date, at the rate of 3.350% per annum.

Section 2.3 <u>Denominations, Medium, Method and Place of Payment, Payment of Interest, Dating and Numbering.</u>

- (a) The 2025E Bonds shall be issued in the form of fully registered Bonds in Authorized Denominations. The 2025E Bonds shall be dated the Closing Date and shall bear interest during each Interest Accrual Period until the entire principal amount of the 2025E Bonds has been paid. Each 2025E Bond shall bear interest from the Interest Payment Date next preceding the date of authentication of such Bond, unless such Bond is authenticated on an Interest Payment Date, in which event such Bond shall bear interest from such Interest Payment Date, or unless such Bond is authenticated prior to the first Interest Payment Date, in which event such Bond shall bear interest from its dated date, or unless interest on such Bond shall be in default, in which event such Bond shall bear interest from the date to which interest has been paid in full or unless no interest shall have been paid on the 2025E Bonds, in which event such Bond shall bear interest from its dated date. Payment of interest on any 2025E Bond shall be made to the Person whose name appears on the registration records kept by the Bond Registrar as the registered owner thereof on the Record Date, such interest to be paid by check or draft mailed to the registered owner at his address as it appears on such registration records or at such other address as it may have filed with the Bond Registrar for that purpose, and the Bond Registrar shall keep a record in such registration records or at such other address as it appears on such registration records or at such other address as it may have filed with the Bond Registrar for that purpose.
- (b) The principal of and interest on the 2025E Bonds shall be payable in lawful money of the United States of America. The interest on the 2025E Bonds shall be paid by the Paying Agent on the Interest Payment Dates, by check mailed by the Paying Agent to the respective Owners of record thereof on the applicable Record Date at their addresses as they appear on the applicable Record Date in the registration records, except that in the case of any Owner of \$1,000,000 or more in Aggregate Principal Amount of 2025E Bonds, upon the written request of such Owner to the Paying Agent not later than 5 (five) Business Days prior the Record Date for such payment, specifying the account or accounts within the United States to which such payment shall be made, payment of interest shall be made by wire transfer of immediately available funds on the Interest Payment Date following such Record Date. Any such request shall remain in effect until revoked or revised by such Owner by an instrument in writing delivered to the Paying Agent. The principal of each Bond shall be payable on the Bond Payment Date, upon surrender thereof at the designated corporate trust operations or agency office of the Paying Agent.

- (c) Interest on the 2025E Bonds shall be computed on the basis of a 360-day year of twelve 30-day months. Payment of interest on each 2025E Bond shall be made on each Interest Payment Date for such Bond for unpaid interest accrued during the Interest Accrual Period to the Owner of record of such Bond on the applicable Record Date.
- (d) Unless the Authority shall otherwise direct, the 2025E-1 Bonds shall be numbered separately from 1 upward preceded by the legend REI1- prefixed to the number, and the 2025E-2 Bonds shall be numbered separately from 1 upward preceded by the legend REI2- prefixed to the number.
- Section 2.4 Form of Bonds and Certificates of Authentication. The form of the 2025E Bonds, including the Bond Registrar's Certificate of Authentication thereon, shall be substantially as set forth in Exhibit A to this Series Indenture. Any 2025E Bonds may contain or have endorsed thereon such provisions, specifications and descriptive words and such opinions and certifications not inconsistent with the provisions of the Master Indenture and this Series Indenture as may be necessary or desirable, as determined by an Authorized Officer prior to their authentication and delivery.
- Section 2.5 <u>Execution of 2025E Bonds</u>. The Chair, the Chair pro tem, the Executive Director, the Chief Operating Officer, and the Chief Financial Officer of the Authority and each of them is hereby authorized and directed to execute the 2025E Bonds, by manual or facsimile signature, and the Secretary/Treasurer, Executive Director or other officer named in this Section 2.5 (other than the officer executing the 2025E Bonds) is hereby authorized and directed to attest, by manual or facsimile signature, the seal of the Authority impressed or imprinted thereon, all in the manner prescribed in Section 2.8 of the Master Indenture.
- Section 2.6 <u>Purposes</u>. The 2025E Bonds are authorized to provide moneys to deposit in the Restricted Loan Subaccount, for the making of the Marshall Pointe Loan. To assist in the financing of the acquisition, construction, and equipping of the Marshall Pointe Housing Facility, the Borrower will cause the Construction Loan Advances to be periodically delivered to the Trustee for deposit into the Collateral Fund Subaccount as security for the 2025E Bonds. The 2025E Bonds are also authorized to pay all or a portion of the Costs of Issuance and to fund all or a portion of the Debt Service Reserve Fund Requirement.

(End of Article II)

ARTICLE III.

REDEMPTION OF 2025E BONDS

Section 3.1 Special Redemption.

- (a) In accordance with and for purposes of Section 5.3(e) hereof, the 2025E Bonds are subject to special redemption prior to maturity, in whole or in part, at any time on or before October 1, 2029 pursuant to an Authority Request filed with the Trustee stating that the Authority no longer reasonably expects to apply the amount to be transferred for the purposes stated in Section 5.3(b) hereof (or such later date as may be selected in accordance with Section 5.3(e) hereof) upon notice as provided in Section 3.4 of this Series Indenture, at a Redemption Price equal to 100% of the Aggregate Principal Amount of the 2025E Bonds or portions thereof to be so redeemed, together with accrued interest to the date of redemption, from amounts transferred to the 2025 Series E Subaccount of the Class I Special Redemption Account from any unexpended proceeds of the 2025E Bonds in the Restricted Loan Subaccount.
- (b) The 2025E Bonds are subject to special redemption prior to maturity pursuant to an Authority Request filed with the Trustee confirming that such redemption is consistent with the most recently filed Cash Flow Statement (as defined in the Indenture), in whole or in part, at any time, upon notice as provided in Section 3.4 of this 2025 Series E Indenture, at a Redemption Price equal to 100% of the Aggregate Principal Amount of the 2025E Bonds or portions thereof to be so redeemed, together with accrued interest to the date of redemption from and to the extent there are moneys and/or Investment Securities in the 2025 Series E subaccount of the Class I Special Redemption Account (other than as described in paragraph (a) above) and/or in the 2025 Series E subaccount of the Revenue Fund and available to be transferred to the 2025 Series E subaccount of the Class I Special Redemption Account on or before the day that notice of redemption is given pursuant to Section 3.4 hereof, but not including moneys or Investment Securities in such subaccounts from the proceeds of refunding bonds or from other moneys of the Authority deposited into the Revenue Fund pursuant to the last sentence of Section 4.6(a) of the Master Indenture.
- (c) The 2025E Bonds are subject to special redemption prior to maturity, in whole or in part, upon notice as provided in Section 3.4 of this 2025 Series E Indenture, at a Redemption Price equal to 100% of the Aggregate Principal Amount of the 2025E Bonds or portions thereof to be so redeemed, together with accrued interest to the date of redemption, if and to the extent that the Marshall Pointe Loan has not been finally endorsed for insurance by the Federal Housing Administration under Section 542(c) of the Housing and Community Development Act of 1992, as amended, by the Risk-Share Insurance Delivery Date (or such later date to which the Authority may consent in writing), or earlier in the event of a Failed Conversion (as described in the Bond Loan Agreement).

The Authority may extend the applicable special redemption date by providing an Authority Request filed with the Trustee of any extension of such special redemption date, provided that the Borrower may be required at the direction of the Authority to deposit funds for

the credit of the 2025 Series E subaccount of the Negative Arbitrage Account in an amount, taking into account amounts already on deposit therein, sufficient to pay interest due on the 2025E-1 Bonds to the extended special redemption date (the "Extension Deposit"). Extension Deposits may continue to be made by or on behalf of the Borrower until the Risk-Share Insurance Delivery Date occurs or the Borrower declines to make an Extension Deposit resulting in the special redemption, at the direction of the Authority, pursuant to Section 3.3(a) hereof; provided, however, the special redemption date may not be extended unless prior to any extension there shall be filed with the Trustee and the Authority an opinion of Bond Counsel to the effect that such extension will not adversely affect the exclusion of interest on the 2025E-1 Bonds from gross income for federal income tax purposes. The cost of such opinion shall be the sole obligation and responsibility of the Borrower.

Section 3.2 Optional Redemption.

- (a) The 2025E-1 Bonds maturing on and after October 1, 2033 are subject to redemption at the option of the Authority, from any source in whole or in part, in Authorized Denominations on any date on or after April 1, 2033, at a Redemption Price equal to 100% of the principal amount thereof plus accrued interest, if any, to the date of redemption.
- (b) The 2025E-2 Bonds are not subject to redemption at the option of the Authority prior to maturity.

Section 3.3 2025 Series E Class I Sinking Fund Installments.

(a) The 2025E-1 Bonds maturing on October 1, 2040 shall be redeemed prior to their maturity, in part, by payment of 2025 Series E Class I Sinking Fund Installments, upon notice as provided in Section 3.2 of the Master Indenture, on each of the dates set forth below and in the respective principal amounts set forth opposite each such date, in each case at a Redemption Price equal to 100% of the principal amount of the 2025E-1 Bonds or portions thereof to be redeemed, plus accrued interest to the date of redemption as follows:

(b) The 2025E-1 Bonds maturing on October 1, 2045 shall be redeemed prior to their maturity, in part, by payment of 2025 Series E Class I Sinking Fund Installments, upon notice as provided in Section 3.2 of the Master Indenture, on each of the dates set forth below and in the respective principal amounts set forth opposite each such date, in each case at a Redemption Price equal to 100% of the principal amount of the 2025E-1 Bonds or portions thereof to be redeemed, plus accrued interest to the date of redemption as follows:

(c) The 2025E-1 Bonds maturing on October 1, 2050 shall be redeemed prior to their maturity, in part, by payment of 2025 Series E Class I Sinking Fund Installments, upon notice as provided in Section 3.2 of the Master Indenture, on each of the dates set forth below and in the respective principal amounts set forth opposite each such date, in each case at a Redemption Price equal to 100% of the principal amount of the 2025E-1 Bonds or portions thereof to be redeemed, plus accrued interest to the date of redemption as follows:

(d) The 2025E-1 Bonds maturing on October 1, 2055 shall be redeemed prior to their maturity, in part, by payment of 2025 Series E Class I Sinking Fund Installments, upon notice as provided in Section 3.2 of the Master Indenture, on each of the dates set forth below and in the respective principal amounts set forth opposite each such date, in each case at a Redemption Price equal to 100% of the principal amount of the 2025E-1 Bonds or portions thereof to be redeemed, plus accrued interest to the date of redemption as follows:

(f) The 2025E-1 Bonds maturing on October 1, 2068 shall be redeemed prior to their maturity, in part, by payment of 2025 Series E Class I Sinking Fund Installments, upon notice as provided in Section 3.2 of the Master Indenture, on each of the dates set forth below and in the respective principal amounts set forth opposite each such date, in each case at a Redemption Price equal to 100% of the principal amount of the 2025E-1 Bonds or portions thereof to be redeemed, plus accrued interest to the date of redemption as follows:

Section 3.4 <u>Notice of Redemption</u>. The 2025E Bonds shall be redeemed as provided in this Article III upon notice as provided in Section 3.2 of the Master Indenture and to the MSRB, provided that notices of redemption shall be given not more than 60 days nor less than 20 days prior to the redemption date.

Section 3.5 <u>Partial Redemption</u>. In the event of a partial redemption of 2025E Bonds, except as otherwise directed by an Authority Request that certifies that such request is consistent with the most recently filed Related Cash Flow Statement, the Bond Registrar shall select a pro rata amount (as nearly as possible given authorized denominations) of 2025E Bonds of each Series and maturity for redemption. If less than all the 2025E Bonds of like Series and maturity are to be redeemed on any one date pursuant to this Article III, the particular 2025E Bonds or the respective portions thereof to be redeemed shall be selected randomly by the Bond Registrar in such manner as the Bond Registrar in its discretion deems fair and appropriate.

(End of Article III)

ARTICLE IV.

APPLICATION OF BOND PROCEEDS AND OTHER MONEYS

- Section 4.1 <u>Proceeds of the 2025E Bonds.</u> The proceeds of the sale and delivery of the 2025E Bonds (or amounts exchanged or deemed exchanged for proceeds of the 2024E Bonds pursuant to the Funds Exchange Agreement) shall be applied as follows:
 - (a) \$63,000,000 shall be deposited into the Restricted Loan Subaccount; and
 - (b) \$2,265,000 shall be deposited into the 2025 Series E subaccount of the Debt Service Reserve Fund.
- Section 4.2 <u>Application of Other Moneys.</u> On the Closing Date, from moneys in the Surplus Account of the Revenue Fund, there shall also be deposited (a) \$995,000 into the 2025 Series E subaccount of the Negative Arbitrage Account, (b) \$300,000 into the 2025 Series E subaccount of the Revenue Fund, and (c) \$780,000 into the 2025 Series E subaccount of the Cost of Issuance Account.
- Section 4.3 No Additional Authority Contribution Required. Other than as provided in Section 4.2 hereof, the Authority shall not be obligated to make any contribution of funds to the Trustee in connection with the delivery of the 2025E Bonds, but the Authority may, at any time on or after the Closing Date, make additional deposits to the Program Fund, including the Restricted Loan Subaccount, the Collateral Fund Subaccount, the 2025 Series E subaccount of the Cost of Issuance Account and the 2025 Series E subaccount of the Negative Arbitrage Account within the Program Fund.

(End of Article IV)

ARTICLE V.

ESTABLISHMENT OF CERTAIN SUBACCOUNTS; APPLICATION OF 2025 SERIES E SUBACCOUNTS OF THE ACQUISITION ACCOUNT

Section 5.1 <u>Establishment of Subaccounts.</u>

- (a) The following subaccounts are hereby created and established as special trust funds within the Funds and Accounts created and established pursuant to the Master Indenture:
 - (i) the 2025 Series E subaccount of the Acquisition Account, which shall consist of the Restricted Loan Subaccount, the Collateral Fund Subaccount and the Construction Loan Prepayment Subaccount;
 - (ii) the 2025 Series E subaccount of the Negative Arbitrage Account;
 - (iii) the 2025 Series E subaccount of the Cost of Issuance Account;
 - (iv) the 2025 Series E subaccount of the Revenue Fund;
 - (v) the 2025 Series E subaccount of the Rebate Fund;
 - (vi) the 2025 Series E subaccount of the Debt Service Reserve Fund;
 - (vii) the 2025 Series E subaccount of the Class I Debt Service Fund; and
 - (viii) the 2025 Series E subaccount of the Class I Special Redemption Account.

Section 5.2 Collateral Fund Subaccount of the Acquisition Account.

The Trustee shall deposit into the Collateral Fund Subaccount all Construction Loan Advances received in accordance with the Construction Loan Agreement and the Intercreditor Agreement. Upon approval of draw requests in accordance with the Bond Loan Agreement, the Intercreditor Agreement requires the Construction Lender to transfer or cause to be transferred the applicable amount of Construction Loan Advances to the Trustee to be deposited by the Trustee into the Collateral Fund Subaccount in a principal amount equal to, and as a prerequisite to the disbursement of, the corresponding amount of Bond proceeds on deposit in the Restricted Loan Subaccount to be disbursed by the Trustee to pay project costs in connection with the Marshall Pointe Housing Facility, all as set forth in the Intercreditor Agreement. Prior to the disbursement by the Trustee of amounts on deposit in the Restricted Loan Subaccount, the Trustee shall receive Construction Loan Advances delivered on behalf of the Borrower for deposit into the Collateral Fund Subaccount. The delivery of such Construction Loan Advances shall

be a prerequisite to the disbursement of a corresponding amount of 2025E Bond proceeds from the Restricted Loan Subaccount or for the benefit of the Borrower.

Money in the Collateral Fund Subaccount shall be used by the Trustee as follows: (i) to the extent money is not otherwise available, the Trustee shall transfer from the Collateral Fund Subaccount to the 2025 Series E subaccount of the Class I Debt Service Fund an amount necessary to pay amounts on the 2025E Bonds when due, notwithstanding whether the Conversion Date has occurred; (ii) if and to the extent that the Marshall Pointe Loan has been finally endorsed for insurance by the Federal Housing Administration under Section 542(c) of the Housing and Community Development Act of 1992, as amended, by the Risk-Share Insurance Delivery Date (or such later date to which the Authority may consent in writing), on the Conversion Date, the Trustee shall transfer from the Collateral Fund Subaccount first, into the 2025 Series E subaccount of the Class I Debt Service Fund, an amount sufficient, together with applicable amounts on deposit therein, to pay in full the principal and interest due on the 2025E-2 Bonds on or before the Maturity Date of the 2025E-2 Bonds, and second, into the Construction Loan Prepayment Subaccount, all remaining amounts in the Collateral Fund Subaccount to pay all or a portion of the amounts due on the Cash Collateral Amount of the Construction Loan pursuant to Section 5.4; and (iii) in the event of a special redemption pursuant to Section 3.1(c), the amounts on deposit in the Collateral Fund Subaccount shall be transferred into the 2025 Series E Subaccount of the Class I Special Redemption Account of the Redemption Fund and shall be used to redeem the 2025E Bonds.

Until the transfer of funds occurs to the Construction Loan Prepayment Subaccount pursuant to Section 5.4, each deposit into the Collateral Fund Subaccount shall constitute an irrevocable deposit solely for the benefit of the Owners of the 2025E Bonds, subject to the provisions hereof.

The 2025E Bonds shall not be, and shall not be deemed to be, paid or redeemed by reason of any deposit into the Collateral Fund Subaccount unless and until the amount on deposit in the Collateral Fund Subaccount is transferred to the 2025 Series E subaccount of the Class I Debt Service Fund or the 2025 Series E Subaccount of the Class I Special Redemption Account of the Redemption Fund, as applicable, and applied to the payment of the principal of any of the 2025E Bonds, or the principal component of the redemption price of any of the 2025E Bonds, all as provided in this Series Indenture.

Section 5.3 Restricted Loan Subaccount of the Acquisition Account.

- (a) Deposit of Moneys to Restricted Loan Subaccount. There shall be paid into the Restricted Loan Subaccount the amount specified in Article IV hereof. There may also be paid into the Restricted Loan Subaccount, at the option of the Authority, any moneys received by the Authority from any other source, unless required to be otherwise applied as provided by the Indenture.
- (b) Restriction on the Use of Moneys. The proceeds of the 2025E Bonds and any other moneys deposited in the Restricted Loan Subaccount shall be used to make the

Marshall Pointe Loan for the acquisition, construction, and equipping of the Marshall Pointe Housing Facility.

- (c) Satisfaction of Requirements of Section 5.7 of the Master Indenture. The Authority hereby certifies that the requirements of Section 5.7 of the Master Indenture have been satisfied with respect to the Marshall Pointe Loan.
- (d) Disbursements from Restricted Loan Subaccount. The Marshall Pointe Loan shall be considered to be fully disbursed upon deposit of the proceeds of the 2025E Bonds pursuant to Section 4.1 hereof for the purposes of computing the amount of interest due each month on the Borrower's Note (as defined in the Bond Loan Agreement) to the Authority. Upon deposit of a Construction Loan Advance into the Collateral Fund Subaccount from time to time, an amount equal to such corresponding deposit shall be disbursed by the Trustee from the Restricted Loan Subaccount for the purpose of paying costs of the Marshall Pointe Housing Facility that are approved by the Construction Lender pursuant to the terms, conditions and provisions of the Construction Loan Agreement, the Bond Loan Agreement and the Intercreditor Agreement. Prior to making any such disbursement from the Restricted Loan Subaccount, the Trustee shall confirm that the sum of amounts that will be on deposit in the Restricted Loan Subaccount and the Collateral Fund Subaccount after the requested disbursement, plus the amount of 2025E Bond proceeds deposited to the 2025 Series E subaccount of the Debt Service Reserve Fund on the Closing Date, will at least equal the then Outstanding principal amount of the 2025E Bonds and, notwithstanding anything to the contrary contained in the Construction Loan Agreement, the Bond Loan Agreement or the Intercreditor Agreement, the Trustee shall not disburse money from the Restricted Loan Subaccount, unless and until Construction Loan Advances in an amount equal to or greater than the requested disbursement amount have been deposited in the Collateral Fund Subaccount.

To the extent money on deposit in the Restricted Loan Subaccount is invested in Investment Securities that have not yet matured, the Trustee is hereby authorized to make the following sale and exchange, which sale and exchange shall occur prior to the disbursement of amounts on deposit in the Restricted Loan Subaccount to pay costs of the Marshall Pointe Housing Facility without the need to sell or terminate such Investment Securities prior to their stated maturity date: (i) liquidate and sell all or a portion of the Investment Securities in the Restricted Loan Subaccount, in the amount specified in the request for disbursement, to the Collateral Fund Subaccount for a price of par and (ii) transfer a like amount of available funds from the Collateral Fund Subaccount to the Restricted Loan Subaccount representing a ratable portion of 2025E Bond proceeds as the purchase price thereof.

Upon the satisfaction of the provisions set forth in this paragraph (d) of Section 5.3, the Trustee shall be irrevocably and unconditionally obligated to disburse 2025E Bond proceeds from the Restricted Loan Subaccount equal to the amount deposited to the Collateral Fund Subaccount, as set forth in the corresponding requisition pursuant to the Construction Loan Agreement, the Bond Loan Agreement and the Intercreditor Agreement, and to the extent the Trustee is unable to do so, the Trustee shall

return the amount deposited in the Collateral Fund Subaccount within one Business Day of receipt of such deposit to the party that made such deposit as set forth in such requisition. The Trustee shall have no duty to determine whether any requested disbursement from the Restricted Loan Subaccount complies with the terms, conditions and provisions of the Construction Loan Agreement, the Bond Loan Agreement or the Intercreditor Agreement.

To the extent sufficient funds are not otherwise available to the Trustee, including money on deposit in the 2025 Series E subaccount of the Debt Service Reserve Fund or the Collateral Fund Subaccount, the Trustee shall transfer from the Restricted Loan Subaccount to the 2025 Series E subaccount of the Debt Service Reserve Fund sufficient money to pay a pro rata portion of the amounts due on the 2025E Bonds.

(e) Unexpended Amounts. Any moneys credited to the Restricted Loan Subaccount that are not used to pay the costs of the Marshall Pointe Housing Facility in accordance with subsection (b) of this Section 5.3, shall be transferred by the Trustee to the 2025 Series E Subaccount of the Class I Special Redemption Account of the Redemption Fund pursuant to an Authority Request filed with the Trustee stating that the Authority no longer reasonably expects to apply the amount to be transferred for any such purpose. Such amounts shall be transferred 30 days before any redemption of 2025E Bonds pursuant to Section 3.1(a) hereof, and not later than October 1, 2029 unless the Authority shall have filed with the Trustee an Authority Request specifying a later date or dates for such transfer, accompanied by a Cash Flow Statement with respect to the 2025E Bonds and an opinion of Bond Counsel to the effect that such action will not adversely affect the exclusion from gross income of interest on the 2025E Bonds for federal income tax purposes, in which case such transfer shall occur on the later specified date or dates.

Section 5.4 <u>Conversion Date Deposits; Construction Loan Payment Subaccount of the Acquisition Account.</u>

On the Conversion Date, the Trustee shall, at the direction of the Authority, transfer from the amounts on deposit in the Collateral Fund Subaccount, first, into the 2025 Series E subaccount of the Class I Debt Service Fund, an amount, together with applicable amounts on deposit therein, sufficient to pay in full the principal and interest due on the 2025E-2 Bonds on or before the Maturity Date of the 2025E-2 Bonds, and second, into the Construction Loan Prepayment Subaccount, all remaining amounts on deposit in the Collateral Fund Subaccount. In the event the amounts on deposit in the Construction Loan Prepayment Subaccount are less than the Construction Loan Prepayment Amount, the Trustee shall deposit additional funds provided by the Borrower into Construction Loan Prepayment Subaccount such that the amount in the Construction Loan Prepayment Subaccount equals the Construction Loan Prepayment Amount. The Cash Collateral Amount of the Construction Loan shall be paid in full on the Conversion Date with such amounts on deposit in the Construction Loan Prepayment Subaccount, and all security related to the Construction Loan shall be released by the Construction Lender. The Construction Loan Prepayment Subaccount shall not be pledged to the payment of the 2025E Bonds and shall not be part of the Trust Estate.

Section 5.5 <u>2025 Series E Subaccount of the Negative Arbitrage Account.</u>

In the event that moneys in the 2025 Series E subaccount of the Negative Arbitrage Account become insufficient, the Borrower may be required at the direction of the Authority to deposit funds for the credit of the 2025 Series E subaccount of the Negative Arbitrage Account in an amount, taking into account amounts already on deposit therein, sufficient to pay interest due on the 2025E Bonds allocable to the bond proceeds deposited to the Restricted Loan Subaccount to make the Marshall Pointe Loan. As further described in Section 4.4(a) of the Master Indenture, any moneys collected by the Authority from the Borrower to reimburse the Authority for any Authority moneys deposited to the 2025 Series E subaccount of the Negative Arbitrage Account shall be and remain the property of the Authority, and shall not be subject to the lien and pledge of the Indenture.

Upon the Conversion Date, certain excess amounts attributable to the Borrower in the 2025 Series E subaccount of the Negative Arbitrage Account shall be paid by the Authority to the Borrower within a reasonable time after the Conversion Date, as further described in Section 4.4(e) of the Master Indenture.

Section 5.6 Closing of 2025 Series E Subaccounts of the Acquisition Account.

Upon final disbursement of all amounts on deposit in the Restricted Loan Subaccount, the Collateral Fund Subaccount, and/or the Construction Loan Prepayment Subaccount, the Trustee shall close the Restricted Loan Subaccount, the Collateral Fund Subaccount, and/or the Construction Loan Prepayment Subaccount, as applicable.

(End of Article V)

ARTICLE VI.

ADDITIONAL COVENANTS

Section 6.1 <u>Servicing Fees</u>. Servicing Fees with respect to the Marshall Pointe Loan shall not exceed the maximum amount consistent with the most recent Cash Flow Statement.

Section 6.2 <u>Tax Covenants</u>. The Authority covenants and represents for the benefit of the Owners of the 2025E Bonds that it will not take any action or omit to take any action with respect to the 2025E Bonds, the proceeds thereof, any other funds of the Authority or any facilities financed with the proceeds of the 2025E Bonds if such action or omission (i) would cause the interest on the 2025E Bonds to lose its exclusion from gross income for federal income tax purposes under Section 103 of the Code, or (ii) would cause interest on the 2025E Bonds to lose its exclusion from alternative minimum taxable income as defined in Section 55(b) of the Code; provided, however, that the Authority makes no covenant with respect to taxation of interest on the 2025E Bonds as a result of the inclusion of that interest in the "adjusted financial statement income" of "applicable corporations" (as defined in Sections 56A and 59(k), respectively, of the Code). The foregoing covenants shall remain in full force and effect notwithstanding the payment in full or defeasance of the 2025E Bonds until the date on which all obligations of the Authority in fulfilling the above covenant under the Code have been met.

Section 6.3 Limitation on Payment of Fiduciary and Administrative Expenses.

- (a) Fiduciary Expenses which may be paid from the 2025 Series E subaccount of the Revenue Fund pursuant to Section 4.6(c)(i)(M) of the Master Indenture may not exceed the amount permitted by the then-current Cash Flow Statement.
- (b) Administrative Expenses and Fiduciary Expenses which may be paid from the 2025 Series E subaccount of the Revenue Fund pursuant to Section 4.6(c)(i)(Q) of the Master Indenture may not exceed the amounts permitted by the then-current Cash Flow Statement.

(End of Article VI)

ARTICLE VII.

MISCELLANEOUS

- Section 7.1 <u>Approval of Investment Securities.</u> The investment of amounts in the 2025 Series E Subaccount of the Acquisition Fund in State and Local Government Series (SLGS) securities is hereby approved.
- Section 7.2 <u>Severability and Invalid Provisions.</u> If any one or more of the covenants or agreements provided in this Series Indenture on the part of the Authority to be performed should be contrary to law, then such covenant or covenants or agreement or agreements shall be deemed severable from the remaining covenants and agreements, and shall in no way affect the validity of the other provisions of this Series Indenture.
- Section 7.3 <u>Table of Contents and Section Headings Not Controlling.</u> The Table of Contents and the headings of the several Articles and Sections of this Series Indenture have been prepared for convenience of reference only and shall not control, affect the meaning of, or be taken as an interpretation of any provision of this Series Indenture.
- Section 7.4 <u>Counterparts; Electronic Transactions.</u> This Series Indenture may be executed in several counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument. In addition, the transaction described herein may be conducted and related documents may be stored by Electronic Means. Copies, telecopies, facsimiles, electronic files and other reproductions of original executed documents shall be deemed to be authentic and valid counterparts of such original documents for all purposes, including the filing of any claim, action or suit in the appropriate court of law.
- Section 7.5 <u>Effective Date; Execution and Delivery.</u> This Series Indenture shall become effective upon its execution and delivery by the Authority and the Trustee.

This Bond constitutes a Class I Obligation (as defined in the Indenture) under the Indenture and is secured by the pledge and lien of the Trust Estate contained therein, which is in the following order of priority: first, to secure the payment of the principal of and interest on the Class I Obligations in accordance with the terms and the provisions of the Indenture, second, to secure the payment of the principal of and interest on the Class II Obligations (as defined in the Indenture) in accordance with the terms and the provisions of the Indenture, third, to secure the payment of the principal of and interest on the Class III Obligations (as defined in the Indenture) in accordance with the terms and the provisions of the Indenture, and fourth, to secure the payment of the principal of and interest on the Class IV Obligations (as defined in the Indenture) in accordance with the terms and provisions of the Indenture. The Registered Owner hereof, by acceptance of this Bond, consents to all of the terms and conditions of the Indenture, a copy of which is on file with the Trustee.

THIS BOND, TOGETHER WITH THE INTEREST HEREON, IS A SPECIAL, LIMITED OBLIGATION OF THE AUTHORITY PAYABLE SOLELY FROM, AND SECURED ONLY BY, THE REVENUES AND OTHER SECURITY PLEDGED THEREFOR UNDER THE INDENTURE, SUBJECT TO THE LIEN AND PLEDGE PRIORITY DISCUSSED ABOVE. IN NO EVENT SHALL THIS BOND CONSTITUTE AN OBLIGATION OR LIABILITY OF THE STATE OR ANY POLITICAL SUBDIVISION THEREOF (OTHER THAN THE AUTHORITY). THE AUTHORITY HAS NO TAXING POWER NOR DOES IT HAVE THE POWER TO PLEDGE THE GENERAL CREDIT OF THE STATE OR ANY POLITICAL SUBDIVISION THEREOF OTHER THAN THE AUTHORITY, OR TO PLEDGE THE TAXING POWER OF THE STATE OR ANY POLITICAL SUBDIVISION THEREOF. THE STATE SHALL NOT BE LIABLE FOR THIS BOND, AND THIS BOND SHALL NOT CONSTITUTE A DEBT OF THE STATE.

Any term used herein as a defined term but not defined herein shall be defined as in the Indenture.

This Bond is transferable, as provided in the Indenture, only upon the records of the Authority kept for that purpose at the designated operations office of the Trustee by the Registered Owner hereof in person, or by his or her duly authorized attorney, upon surrender of this Bond together with a written instrument of transfer satisfactory to the Trustee duly executed by the Registered Owner or his or her duly authorized attorney, and thereupon a new registered Bond or Bonds, and in the same Series, maturity and aggregate principal amounts, shall be issued to the transferee in exchange therefor as provided in the Indenture, and upon payment of the charges therein prescribed. The Authority and the Trustee shall deem and treat the person in whose name this Bond is registered as the absolute owner hereof for the purpose of receiving

payment of, or on account of, the principal or redemption price hereof and interest due hereon and for all other purposes.

The Bonds are in registered form without coupons in the denominations of \$5,000 or any integral multiples of \$5,000 ("Authorized Denominations"). The Owner of any Bonds may surrender the same at the above-mentioned office of the Trustee, in exchange for an equal aggregate principal amount of Bonds of the same Series and maturity of any of the Authorized Denominations, in the manner, subject to the conditions and upon the payment of the charges provided in the Indenture. Pursuant to Section 29-4-722 of the Act, Bonds issued under the Act shall be negotiable instruments under the laws of the State, subject only to applicable provisions for registration.

This Bond bears interest on the Principal Amount specified above, payable to the Registered Owner hereof on each April 1 and October 1, commencing April 1, 2025, at the Interest Rate per annum specified above, until maturity or earlier redemption. Interest on the Bonds shall be computed on the basis of a 360-day year consisting of twelve 30-day months.

The principal or Redemption Price (as defined in the Indenture) on each Bond will be payable in lawful money of the United States of America at the designated operations office of the Paying Agent in St. Paul, Minnesota, or its successors as Paying Agent under the Indenture. At the written request of any Owner of at least \$1,000,000 Aggregate Principal Amount of Bonds delivered to the Bond Registrar not later than five (5) Business Days prior to the Record Date during any time while the Bonds are not in book-entry form, the principal or Redemption Price of and interest on the Bonds may be paid by wire transfer within the United States to the bank account number of such Owner on the registration records. In case of any such payment by wire transfer, the CUSIP number or numbers of the Bonds being paid shall be included in the wire transfer.

Certain of the Bonds are subject to special, optional redemption and mandatory sinking fund redemption in the manner, at the prices, at the times and under the circumstances provided in the Indenture.

The Indenture provides that the occurrences of certain events constitute Events of Default. If certain Events of Default occur, the Trustee may, and upon the written request of the Registered Owners of a sufficient percentage in aggregate principal amount of Outstanding Bonds (as provided in the Indenture) shall, give 30 days' notice in writing to the Authority of its intention to declare all Outstanding Bonds immediately due and payable. At the end of such 30-day period, the Trustee may, and upon the written consent of the Owners of a sufficient percentage in aggregate principal amount of Outstanding Bonds (as provided in the Indenture) shall, declare all Outstanding Bonds immediately due and payable. An Event of Default and its consequences may be waived as provided in the Indenture. Registered Owners may not enforce the Indenture or the Bonds except as provided in the Indenture.

If any moneys held by the Trustee or Paying Agent in trust for the payment of interest on or principal of any Bonds remain unclaimed for a period of three years after the date on which such moneys were payable, the Trustee or Paying Agent will, upon written notice from the Authority, pay such amounts to the Authority, as provided in the Indenture. Thereafter, such Registered Owners must look to the Authority for payment of such moneys.

The Act provides that neither the members of the Authority nor any authorized person executing bonds issued pursuant to the Act shall be personally liable for such bonds by reason of the execution or issuance thereof.

IT IS HEREBY CERTIFIED, RECITED AND DECLARED that all acts, conditions and things required by the Constitution and statutes of the State and the Indenture to exist, to have happened and to have been performed precedent to and in the issuance of this Bond, exist, have happened and have been performed in due time, form and manner as required by law.
